Pastor's Letter Rev. Timothy T. Boggess

2023 was an encouraging year. Our worship attendance increased, our giving increased and our serving others increased over the previous year. And, even though we lost 31 members through death, moves, and transfers of membership, we also welcomed 14 new members into our church family. We have a lot to be thankful for.

The highlights of the year for me were:

- the trip to Cuba in February to spend a week with the members of Juan G. Hall Presbyterian Church, taking with us 1,500 pounds of much-needed supplies and coming home with hearts full of hope and love;
- being installed as your new pastor;
- leading confirmation class for our fun and amazing junior high and senior high youth;
- giving weekly children's sermons on the stage at the New Song service;
- paddling in a dragon boat at Nathan Benderson Park on a brutally hot July afternoon with other dehydrated members to celebrate our "Step in the Boat" Sunday School theme;
- celebrating Ron and Jinny Miller's faithful shepherding of our ministry with the children and families of Brentwood Elementary School;
- kayaking around Little Sarasota Bay with a group from the church, with a stop at the Turtle Beach Grill before heading home;
- the Rise Against Hunger event in December in which over seventy volunteers packed 14,000 meals to be sent overseas;
- teaching my Wednesday Bible study; and
- watching our children tell the Christmas story at the Family Christmas Eve service.

Spread upon these pages you will read about the things that I mentioned, and more. I hope also you will take the time to read through these reports of what God is doing in our midst. I hope that you will join me in rejoicing in the lives that are being changed through our work and worship. Especially if that life is yours.

The apostle Paul captures my thoughts about you perfectly when he writes:

"I don't stop giving thanks to God for you when I remember you in my prayers. I pray that the God of our Lord Jesus Christ, the Father of glory, will give you a spirit of wisdom and revelation that makes God known to you. Music Ministry Steven Phillips, Director of Music

As Director of Music, I am privileged to work with many talented and dedicated people, including our music teams, tech team, officers, members, and staff.

I want to start by thanking our choir members, who give their time and talents each week. I'm equally grateful for the New Song Band for their faithful leadership, and for the band's co-leader, Ted Eastmoore.

As our church continues to grow beyond the pandemic, we have begun to find a new stride in our choir and our band. We continue to invite talented guest musicians to enrich our services on a regular basis. Oak Street Stage, our community outreach venue, is now becoming more feasible, as we hosted one concert last Spring with the Lubben Brothers Band, and one concert by virtuoso jazz pianist David Meder and his outstanding band.

A highlight of 2023 was the annual Celtic Christmas concert on Friday, December 8. Last Fall our choir officers, chaired by Susan McDonald, made the decision to invite a partnership with the civic choir Musica Sacra, whom I also direct, making a total choir of nearly 50 singers. Our Celtic instrumentalists were the multi-talented Lubben Brothers of West Palm Beach, joined by other stellar players from the area. Movement and color came with the Riverview High School Highland Dancers, and from our own dancer-choreographer, James Jordan. With a more-than-capacity audience, the need has been demonstrated for two performances in 2024, which are slated for December 13 and 14, 2024.

I'd like to celebrate the role that FPC has come to play in our city as an incubator for the arts. Through the exacting logistical work of our Operations Manager, Rachel Martin, about a dozen performing arts organizations regularly use our campus as a venue, making us the most artspositive church in Sarasota. For this reason, we have begun to envision a more organized way of nurturing relationships and welcoming arts-loving people into our spiritual family. In the upcoming year, we plan to design and implement the FPC Arts Advocate Program, which will rely heavily on interested church members to act as hosts to our local arts organizations and to the thousands of people who enter our doors for events.

I conclude by commending our Worship and Music Committee, under co-chairs Frank Frey, and Jeff Bartell which has worked tirelessly to provide our services with ushers, communion elements, and wise and timely oversight.

I am grateful to be part of this loving spiritual community!

First Presbyterian Preschool Clare Carter, Director

We are celebrating seventy-five years of early childhood education! In September 1947, Pastor J. Lowery Bowman and the session of First Presbyterian Church proposed the development of a weekday kindergarten. The school opened, providing preschool education in a Christian setting for forty-eight students under the direction of Mrs. Nell Horton and three dedicated teachers.

At that time, Sarasota County did not offer kindergarten, and the school became an immediate success. Today, we are grateful to our church for supporting and believing in this critical children's ministry as a service to our church and the families of our community.

The need for early childhood education has evolved over the years, and our preschool has, too. With the opening of public kindergartens in the early 1970s, the preschool evaluated the community's needs, added classes for younger children, and extended the hours to make high-quality care available to working parents. With the opening of more daycare centers, afternoon enrollment dropped, and we returned to concentrating on morning classes for children two-anda-half years old through the pre-kindergarten year.

In 2005, Florida implemented a free voluntary pre-kindergarten for four and five year olds, and the preschool again needed to access the program. In 2010, we began to offer parenting classes, and in 2014, we opened a new preschool class for two year-olds.

Parent Educators, Emily Weitekamp and Evan Morgan, facilitate our parenting classes called Small Beginnings. The classes focus on parenting topics such as understanding typical child development, behaviors related to development, toileting, feeding, play at each stage of development and its importance, the parent-child relationship, and self-care. They are structured to facilitate parents connecting and developing a strong web of support.

Our preschool community is a place for parents to find support and make connections. In addition to offering our students the highest quality early childhood education and parenting support for young families, we provide screenings for speech, language, and occupational therapy. We are blessed to have a relationship with an occupational therapist and a speech and language pathologist who offer free screenings for all our students.

It has taken three years to rebuild our program after the pandemic, and today, we are happy to report we have sixty-five students and a staff of sixteen. And last April, we were thrilled to celebrate our seventy-fifth anniversary!

We are grateful to First Presbyterian Church for providing us a home and feel blessed for the church's commitment to our community's children and families. It's clear that Jesus' reminder to "let the little children come" has been the guiding principle during the past seventy-five years.

Health and Wholeness Ministry Cheryl Track, RN-BC, Faith Community Nurse

We believe every life is a sacred gift from God. We believe health and wholeness is a part of the human unity that is inspired through the body, mind and spirit.

I was faithfully supported by the Health and Wholeness Ministry Team comprised of Karen Eastmoore and Jinny Miller. Although we no longer met regularly, we continued to focus on caring for and connecting with the congregation and community. The Care Team consisting of Pastor Tim Boggess, Rev. Doug DeCelle, Michael Fingerle, and Pat Higgins met weekly via Zoom, and then reached out by phone or visit to those with health care needs. The Care Team collaborated with the Deacons and Stephen Ministers in providing congregational care.

The Ministry's Community Outreach

- January: 17 attended Stop the Bleed.
- May: I participated in Blessing of the Hands at Sarasota Memorial Hospital.
- June: 11 people were screened and 7 units of blood and 2 units platelets were collected at the SunCoast Blood Centers Drive.
- September: 10 people were screened and 9 units of blood were collected at the SunCoast Blood Centers Drive.
- October: 14 attended a CPR class.
- October: I participated in the Mission Fair at First Presbyterian.
- September: I met with Stephen Ministers to share community resources.
- December: 14 people were screened and 14 units of blood were collected at the SunCoast Blood Centers Drive.
- December: I attended the Meet and Greet for the new class of deacons.
- The Depression, Bipolar Support Alliance (DBSA) continued to hold weekly support groups, at First Presbyterian.
- The National Alliance on Mental Illness (NAMI) continued to meet at First Presbyterian, offering a 12-week Family-to-Family Class both in person and online.

The Ministry's Care to the Congregation

- 285 phone calls were made to parishioners and received 74 phone calls from parishioners.
- Made 43 referrals to resources in the community.
- Provided 18 series of Journeying through Grief.
- Made 5 home, 45 facility, 17 hospital, and 2 hospice visits.
- Provided transportation for 6 parishioners.
- Gave prayer shawls to 12 people.
- Attended weekly care team meetings and monthly faith community nurse meetings.
- Provided monthly articles for *News at First* as well as correlating information posted in bathrooms.
- Checked two AEDs and two first aid boxes.
- Continued to served as the health professional resource to Deacons, Stephen Ministry, and First Presbyterian Preschool.

Business Affairs Committee Mary Willis and Bob Wrobel, Co-Moderators

The Business Affairs Committee recommends to the Session the allocation of our financial resources to accomplish the mission of FPC and strives to provide an inviting, functioning and safe church campus for the congregation and guests.

Property Ministry Team

Team members included Victor Garraus, Sexton Darwin Goldsmith, and staff liaison, Operations Manger, Rachel Martin. Darwin Goldsmith continued to be a valued member of our staff exhibiting a mastery of the skills required to maintain our large and aging campus. Continued thanks go to Victor Garraus and Scott McLeod who volunteered so much of their time working tirelessly to maintain our campus. Darwin, Victor, and Scott were joined for a spring clean-up by a team of volunteers refreshing plantings, clearing trash, and spreading mulch throughout the campus.

At our January 2023 Business Affairs meeting, we determined that getting back-to-basics would be a guiding principle for the year. The first step in that direction was to take on the fiscal and physical challenge of replacing existing windows in the administration buildings and education wing with hurricane-rated windows. After lengthy discussions, a review of the risks involved and numerous vendor quotes, a decision was made, and deposit given to Mullet Aluminum to secure the order with expectation on delivery in October and installation in December. The project is coming to completion with the new windows improving the safety, security, and appearance of our church buildings. We look forward to a reduction in our energy costs as well.

Under Rachel's leadership, we have expanded the use of our campus by both non-profit and for -profit organizations. Always seeking mission-aligned opportunities, Rachel has had significant success in increasing our revenues from rental of unused space to offset ever-increasing costs associated with utilities, repairs, and maintenance of our campus. We are home to an ever-expanding list of arts organizations for rehearsals, performances, and concerts including the recent Perlman Music Program Suncoast, when students from all over the county used classrooms as rehearsal space for several days, culminating in an evening concert. Additionally, we are a much-needed site for weekly and monthly meetings of several self-help groups under the guidance of Cheryl Track, Faith Community Nurse. Our outreach to the food insecure continues through our weekly All-Faiths Food Bank distribution program. In recent weeks, volunteers from our extended church family serves more than 100 families providing food for more than 242 people. Of equal importance was the opportunity to serve God and our neighbors, by sharing time, good will, and some much-needed food.

While waiting for the new windows, our property team was busy with roof leaks and air conditioning issues. In July we switched to a new HVAC vendor who has more expertise in our type of HVAC system. With the guidance of AAPair, our AC system has been repaired and upgraded with an investment of over \$50,000. With these necessary improvements we now have a workable system in place as well as a valued partner in its maintenance.

A solution to a long-standing issue with access to the chancel in the sanctuary for those with mobility challenges presented itself in the form of a chair lift. The combined efforts of our staff, elders and committee members have resulted in the installation of an ADA compliant chair lift allowing access to our members and guests. The stair lift was paid for with memorial funds.

Finance Ministry Team

Team members include Reva Mitchell, Stephen Mitchell, Ric Saba, Larry Schaper, and new members Andy Copa and Wendy Miller.

Coming off a challenging 2022, and a reduced budget for 2023 forecasting continued shortfalls, the finance team determined to get back-to-basics by examining our assets. The initial action to simplify online giving reduced redundancies while directing funds to areas in greatest need. In partnership with session and committee members, a review of balance sheet accounts noted as Temporarily Restricted, resulted in securing needed funding for programs while meeting their noted restrictions. Looking for additional revenue, Treasurer, Reva Mitchell, and new team member, Andy Copa, took on investing as we noted rising interest rates. Assisted by Lisa Garcia, Finance Manager, the diversification that included investing current assets in T-Bills and CDs and improving interest provided by existing relationships, increased our interest income by \$40,425 or 700% while establishing our compliance with FDIC regulations. Asset review continued as new team member Wendy Miller reviewed funds held as memorial donations and opportunities to employ those gifts while honoring memories of loved ones. The installation of the chancel chair lift is an example of her work. Working with the preschool board and staff with all recognizing the ever-increasing costs of managing our beautiful campus, we received a commitment from the preschool to contribute to the common area maintenance of our shared use space. The amount contributed for 2023 was \$12,000 increasing to \$18,000 for 2024 targeting a 10% of costs ceiling with future contributions determined through the budget process.

Calendar year 2023 summarized financial information is presented in the financial section of this report. It must be noted that from a financial perspective we had a very good year finishing with pledges in excess of budget and both the church and the preschool operating in the black and ahead of budget.

Reva Mitchell, Treasurer, and Lisa Garcia, Finance Manager, provided the accounting associated with the receipt of pledges, other revenue, expenses, and payment of invoices. The annual audit was prepared by Kenneth F. Kandefer, certified public accountant.

The budget for 2024 was approved by session at the December 2023 meeting.

Stewardship Ministry Team

With the inspiration of our Pastor Tim Boggess and leadership provided by Beth Byron Reasoner and David Householder, session elders took on the responsibility for the challenge of raising funds through our annual giving campaign. While the entire process was streamlined and timeline truncated, the challenge was great. Pastor Tim set the goal at an increase in pledge income of 20% for a target of \$880,000. Recalling the tale of *The Boys in the Boat* and its message of pulling together to achieve never imagined results, we were all asked to "get in the boat" and respond to God's call to give generously. And you did...

Pastor Tim has shared that the response from leadership and the congregation with pledging and pledging at an increased amount has been very encouraging. As of January 19, 2024 we had received pledges of \$884,463 from 183 pledges. Please know that having been gifted with a huge response to this call, your session and staff will continue to examine every expenditure and revenue opportunity and will make the challenging decisions necessary to continue to be honored by your faith and trust.

Education and Formation Committee Carrie Mills and Emily Weitekamp - Co-Moderators

The Education and Formation Committee provides Christian growth opportunities to people of all ages, through relationship-building with Christ and others to learn and share about their faith journey, wherever they are.

Children and Youth Education and Formation:

We began the year continuing the *Follow Me* curriculum, which teaches biblical practices for faithful living in four to six-week units. Pastor Tim, along with mentors George Chorba, Leah Cotter, Susan DeWyngaert, and Mariah Martin, began leading five of our youth in a confirmation class that culminated on Youth Sunday in May.

In February, we celebrated Preschool Sunday by showcasing stations of "play-based learning" in the courtyard and around the fellowship hall in between services. Our committee has worked hard to strengthen the relationship between the church and preschool this year, inviting preschool families to attend church events whenever possible.

In June, we partnered with Cedarkirk to host Traveling Day Camp. Approximately 40 children participated with six youth volunteering.

Sunday School classes began again in August, kicked off by the annual Backpack Blessings and a Rally Day themed "Step in the Boat." The committee chose a new curriculum titled *Living the Word*, which follows the Narrative Lectionary that Pastor Tim is using to guide his sermon schedule. Sunday school classes are broken into three groups: PreK to 2nd, 3rd to 5th, and middle/high school youth.

We ended the year with a beautiful Family Christmas Eve Service coordinated by Leah Cotter and the youth, with the help of parent volunteers.

Adult Education and Formation:

The Academy for Christian Discipleship continued with many opportunities for our adult learners. John Parks's adult class began in January, discussing six short stories to discover what they reveal about the human condition. Beginning in February, Janet Olshewsky and Michael Fingerle led a class titled "From Age-ing to Sage-ing" on Zoom, which explored a profound new vision of growing older. In April, Leah Cotter facilitated a book discussion on *To Be Made Well* by Amy Julia Becker during the fellowship hour on Sundays. Through Zoom, Elaine Barnett taught *Reading the Bible for Understanding* in the spring, *The Prophets Still Speak* over the summer, and *Meeting Jesus in the Gospel of John* in the fall. Over the summer, we launched another "FPC Reads" with *The Boys and The Boat*. Readers gathered to discuss the book informally during the coffee hour, and we hosted a culminating Dragon Boat outing at Benderson Park in August.

Intergenerational

We successfully coordinated three annual holiday celebrations with the Palm Sunday Easter Egg Hunt, Pumpkin Carving Festival, and the Advent Workshop.

We hosted Rise Against Hunger in December with approximately 75 volunteers, where we packed 14,000 meals!

We are grateful for those who have given their time and talents to guide our mission throughout the year. In addition to the adult class educators, we appreciate the work of our children and youth class teachers: Clare Carter, Lydia Chapdelain, Leah Cotter, Christine Harrington, Mariah Martin, Scott McLeod, Sandi Soper, Emily Weitekamp and substitutes Rebecca Clissold, Rich Dulaney, and Shelley Watson.

Members of the committee were Elaine Barnett, Leah Cotter, Rebecca Clissold, Christine Harrington, Mariah Martin, Rose Monahan, Sandi Soper, with co-moderators Carrie Mills and Emily Weitekamp, and staff liaison Rachel Martin.

Congregational Nominating Committee Dick Clapp and Karen Olson, Co-moderators

To maintain our representative form of government, the Congregational Nominating Committee thoughtfully proposes a slate of Christ-centered candidates for consideration by the congregation to fill leadership positions at First Presbyterian Church, Sarasota; and as needed, various search committees.

The Nominating Committee considers and proposes a slate of nominees to fulfill the offices of elder (whose charge is one of leadership, discernment, and spiritual development of the church), and deacon (whose role is that of compassion, witness, service, and sharing the love of Jesus Christ). The Nominating Committee also recommends members for the following year's Nominating Committee whose members are charged with seeking individuals who are ready to answer the call to serve.

The committee met with the pastor to review the guidance, position descriptions and the process of calling/emailing/meeting with potential nominees. The committee initially met weekly via Zoom in March to identify and nominate elders, deacons, and at-large members of the Nominating Committee to lead First Presbyterian Church. Information on the positions descriptions was shared with potential nominees.

The Congregational Meeting was held on September 10, 2023. The Nominating Committee presented five members as potential elders in the class of 2026 along with one member for the class of 2025, four members to fill the deacon class for 2026 along with one member for the class of 2025, and nine at-large members to serve on the Nominating Committee. The congregation approved all of the nominees.

The 2023 Nominating Committee members were Elders Dick Clapp and Karen Olson, co-moderators and at-large members Elaine Barnett, Ed Clissold, Kay Dunn, Pat Higgins, Scott McLeod, Virginia "Jinny" Miller, Carolyn Simmons, and Sandi Soper. One member resigned to accept an unexpired term as elder. There was no deacon representative. We are thankful to each of them for their work and dedication on this committee and for their contributions to the life and leadership of our church.

Membership and Fellowship Committee Sue Nurczyk and Sue Hargis Spigel, Co-moderators

The mission of the Membership and Fellowship Committee is to be intentional about attracting and welcoming new members while engaging the congregation and community in activities that promote Christian fellowship within the life and ministry of First Presbyterian Church.

In 2023, the committee provided a variety of refreshments on Sundays at the 10:00 fellowship hour. We always searched for ways to provide a welcoming atmosphere for members and guests.

- As in 2022, committee members sent birthday greetings to members of the congregation either by email or U.S. Mail. For mailed cards, we used the church's return address, which apprised church staff of returned or outdated addresses.
- Committee members and helpers provided refreshments and cleanup before and after the Fellowship hour at 10:00 every Sunday. This is held between the two regular services, or after single service Sundays.
- Membership and Fellowship oversaw three potluck brunches/lunches: February 19, April 2 (Palm Sunday), and October 1 (World Communion Sunday). This included setting up, decorating, preparing food and beverages, receiving food from the congregation, and cleaning. Another major reception (cookies and punch) was held in the evening, after the Celtic Christmas concert and involved the same set of tasks for the committee as previously mentioned.
- February 19: On Jazz Sunday, an omelet and brunch potluck was enjoyed.
- March 19: An elegant installation reception with a charcuterie buffet by Jenn Stutler was held for Rev. Dr. Tim Boggess. We had a large group participating from inside and outside of FPC.
- <u>April 2: Palm Sunday:</u> Two new families from Brentwood and four from preschool attended the egg hunt, as a result of our targeted outreach to those two groups.
- May 14: Mothers Day was acknowledged with the distribution of flowers.
- <u>September 9</u>: A kayak outing event was organized with a lunch at a local restaurant after the paddle.
- October 1: Potluck on World Communion Sunday, after the one 10:00 service
- October 8: Tim's one-year anniversary at FPC was celebrated!
- <u>December 8</u>: A cookies and punch reception was held after Celtic Christmas concert.
- <u>December 10</u>: Snacks from the 10;00 coffee hour were provided to the hosted Inquirers' Class. Six inquirers became new members and indicated their areas of interest in church service.

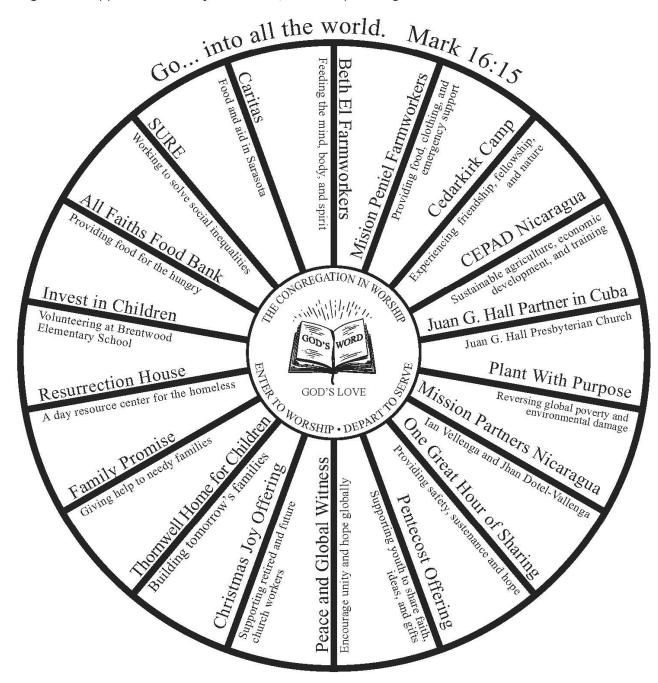

In addition to providing support and guidance to all the committees, church groups and church activities, Rachel Martin, Operations Manager, and Lisa Garcia, Finance Manager, took on many of the tasks once handled by the Assistant to the Pastor. We are grateful for their faithful and dedicated service and for all the ways they support the ministries of the church.

Jimi Camastro, Tech Manager, worked with a team of volunteers to meet the audio-visual needs for both our in-person and online services. He also shared his musical talents, when needed, as a guitarist in the New Song band.

Darwin Goldsmith worked with staff and committee members to make our facilities welcoming to all who come onto the campus. Electrical power was recently added to his work shed, which will make his work even more efficient. Our church campus looks fantastic!

Cheryl Track, Faith Community Nurse, provided direction for the Health and Wholeness Ministry Program and our Congregational Care Team - Doug DeCelle, Pat Higgins, Michael Fingerle and Tim Boggess - to offer support and care to congregational members in their time of need.

Special thanks to committee members Adam Martin, Jean Martin, Jean Raskin, and Kay Steinman. Their valuable experience is most appreciated, and we thank them for serving the church in this capacity.

Worship and Music Committee Frank Frey and Jeff Bartell Co-moderators

The Worship and Music Committee works with staff in planning and supporting worship that enables the congregation to glorify God through worship.

In 2023, the Worship and Music Committee continued to work closely with session to discern the safest practices for worship due to COVID-19 while holding traditional, contemporary, and online services. On March 19, 2023, we installed our new Pastor and head of staff, the Reverend Doctor Timothy T. Boggess. Our congregation was blessed with the gifts and talents of the chancel choir, New Song band, handbell choir, and talented guest musicians.

THE FOUNDATION FOR FIRST PRESBYTERIAN CHURCH OF SARASOTA, INC. 2023 ANNUAL REPORT

First Presbyterian Church first established endowment funds in 1992 to allow members and friends of the church an opportunity to provide long-term support of the church and its mission. In 2013, the Session authorized the formation of the Foundation for First Presbyterian Church of Sarasota, Inc. as a separate 501(c)(3) corporation and transferred the existing endowment funds to the Foundation.

The Foundation is managed by a board of seven directors who are members of First Presbyterian Church of Sarasota. Four directors are appointed by the Session, and the remaining three are elected by the appointing directors.

The directors serving in 2023 were: Betsy Marshall (President), Michelle Young (Secretary), Rich Paul (Treasurer), Richard Clapp (Director), Ric Saba (Director)., and Michael Brown (Director). The one remaining vacancy left by Beth Byron-Reasoner's resignation in 2022 remains to be filled by appointment of the Session.

In 2023, the Foundation primarily focused on keeping the membership informed about opportunities to give to the Foundation by brochures, mailings, and articles in church publications. In the coming years, the Foundation plans to steadily and more actively increase its profile in the giving of the church.

During 2023, the record-keeping and accounting functions of the Foundation were performed by a private accounting firm, Miles and Thirion, for continuity of service. The Foundation is very grateful to and relies on the assistance of the church's office staff as well.

In 2023, the Bylaws of the Foundation were amended to increase the annual distribution to 5% to meet the threshold for distributions from private foundations. Although the Foundation began operations as a public charity, the Foundation was advised by its accountant that its tax exempt classification was recently changed to a private foundation.

The Board of Directors of the Foundation is pleased to report that during 2023 distributions from its funds were made to the Session to further the ministries of the church as follows:

From the Scholarship Endowment Fund: \$7,085.52 From the Property Endowment Fund: \$11,353.94

From the Ministry and Benevolence Endowment Fund: \$11,039.67

From the General Endowment Fund: \$36,183.67 From the Temporary Fund sweep account: \$179.53

As of December 31, 2023, the assets of the Foundation are held in a single account at Charles Schwab and are invested in a selected group of funds approved by the directors. The account activity is monitored by the Treasurer and overseen by the directors.
